**Item 1:** Meeting Called to order at 7:01 pm

**Item 3:** Review minutes of the April 26, 2016 meeting of the Selectboard. Ms. Ludlam made motion to accept the minutes as written, seconded by Mr. Cleveland motion carried, voted and approved.

**Item 4:** Appearances by Local Citizens and Visitors

Ms. Reid would like to clarify that the Ladies Auxiliary in West Pawlet has supplied the flags for both village centers for many years. She agrees the town should now begin assuming responsibility for the purchase of the flags and materials, allowing the Ladies Auxiliary to fundraise for other projects. The selectboard and the Town of Pawlet is very thankful that the Ladies Auxiliary help in fundraising for the flags.

Ms. Reid asked the board about moving the monument in West Pawlet. Mr. Beecher stated that the monument presents a safety hazard. Ms. Reid asked that she kept abreast of plans as they develop. There are no plans right now.

Larry Leslie is attending representing himself and Marty Kravitts, to follow-up on his visit in October. Mr. Leslie has problems with people speeding because people go too fast. Mr. Kravitts thinks that the town should pave the road. Mr. Leslie feels that the town taxes his home and property an inordinate amount and the dust decreases the value of his home. Mr. Beecher explained that the town has tried to connect to with the Better Road program to have them look at the road. We are also in the process of prioritizing road problems and that this section of the road is on the list. Mr. Jones added that any project on that road requires an engineer. Mr. Leslie asks that the constable patrol the road. Mr. Leslie stated that he tries to slow people down my waving them down. Mr. Leslie asked if there could be more signage posted on the road to slow drivers down. Mr. Leslie also mentioned that the Luders and Kravitts's driveways washout because of the road.

**Item 5: Announcements**

The next regular meeting of the select board on May 24<sup>th</sup>, 2016 will be held at the town's Gravel Pit located in North Pawlet off of Route 30 from 7:00 pm to 7:45 pm. The meeting will reconvene at 7:55pm at the Pawlet Town Hall.

**Item 6: Reports****1. Road Foreman's Report-**

- a. Gravel crushing is ongoing in the Town Gravel Pit.
- b. Mr. Mason presented a proposal from Mr. Sheldon to trade mason sand for gravel.
- c. Mr. Beecher asked if they could mix heavier tailings into the gravel mix and the board discussed possibilities.
- d. Everything has been graded.
- e. The road crew has been applying calcium chloride, however applicator and trailer need work.
- f. First slate project should be Wait Hill Rd.
- g. Tadmer Rd should take 2 weeks to complete.
- h. North Pawlet Rd should take 2 weeks to complete
- i. AOT awarded grants of \$16,000 to true and level River Rd. The grant application to pave Rt 153 has been denied.
- j. Mr. Beecher and Mr. Jones discussed safety at the slag pile. Mr. Weeden is concerned about using the rubber-tired loader at the slag pile and possibly damaging the tires.

**2. Zoning Administrator's Report**

- a. Mr. Mach attended the regional planning commission meeting. Mr. Mach asked that \$1,500 be approved to have help from the regional planning commission help write the flood plain regulations and river corridor regulations. The consensus of the board is that Mr. Mach should hire the Rutland Regional Planning Commission to help modify the by-laws.
- b. Mr. Mach would like to add to a park and ride to the zoning bylaws.
- c. The village center designation is complete but there are adjustments that need to be made to the maps.
- d. Mr. Mach would like to attend a zoning and planning meeting at Lake Morrey for \$80.
