

UNION SCHOOL DISTRICT #47 WARNING

The legal voters of Union School District #47, consisting of the Pawlet Town School District and the Rupert Town School District, are hereby notified and warned to meet at the Mettawee Community School on Wednesday, February 24, 2016 at 7:30 PM to consider and act upon the following articles (Articles 1-8) and to discuss the article to be voted upon by Australian ballot (Article 9).

To be acted upon on Wednesday, February 24, 2016:

- Article 1: To elect a Moderator to serve from July 1, 2016 through June 30, 2017.
- Article 2: To elect a School District Clerk to serve from July 1, 2016 through June 30, 2017.
- Article 3: To elect a School District Treasurer to serve from July 1, 2016 through June 30, 2017.
- Article 4: To fix the salaries of School District officers and directors for the fiscal year beginning July 1, 2016.
- Article 5: To determine the date and time on which the 2017 Annual Meeting of Union School District #47 shall be held, and where such meeting shall be held.
- Article 6: Shall the voters authorize the School Board to borrow money by issuance of notes not in excess of anticipated revenue for the fiscal year July 1, 2016 through June 30, 2017?
- Article 7: To discuss the budget to be voted upon by Australian ballot (Article 9).
- Article 8: To transact any other business which may legally come before this meeting.

To be voted on by Australian ballot on Tuesday, March 1, 2016:

- Article 9: Shall the voters of the school district approve the school board to expend \$3,620,019, which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$15,856 per equalized pupil. This projected spending per equalized pupil is 1.79% higher than spending for the current year.

For the purpose of voting by Australian ballot:

Voters of the Pawlet Town School District will vote at the Town Clerk's Office in Pawlet. The Polls will open on Tuesday, March 1, 2016 at 9:00 AM and close at 7:00 PM.


Voters of the Rupert Town School District will vote at the Rupert Town Office in West Rupert. The Polls will open on Tuesday, March 1, 2016 at 10:00 AM and close at 7:00 PM.

At the closing of the polls, the Town Clerks or designees shall appoint a member or members of the Board of Civil Authority to transport the sealed container or containers to the Clerk of the Union School District at the Pawlet Town Clerk's Office whereupon the appointed members of the Boards of Civil Authority will count the co-mingled ballots for the budget (Article 9) under the supervision of the Union District Clerk.

The legal voters of Union School District #47 are further notified that voter qualification, registration, and absentee voting relative to said annual meeting shall be as provided in Section 706(u) of Title 16, and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.
