#### Item 1: Meeting Agenda

# **Item 2: Minutes of Sept. 25th Meeting**

Frank Nelson spoke about a heat pump that could be attached to an existing hot water tank in a home for added efficiencies.

### **Item 4: Zoning Administrator's report**

Elaine Decker submitted a printed compilation of all the houses in West Pawlet and Pawlet. It included their condition rating, year built, where it exists, house site value (house and 2 acres or less on which it is sited) but not additional acreage.

Eric Mach wanted to get a sense of the housing stock to better understand a direction that the towns might go toward economic development.

Wayne Clarke asked the board's opinion of West Pawlet's health economically. Karen Folger noted that the loss of the town store was a big impact and that without employment opportunities the outlook was somewhat bleak. However, she suggested a focus on tourism, using already existing rail trails and slate history as a draw. She used the Slate Valley Museum as an example. The listers explained how a reducing factor was used on houses in the village of West Pawlet for assessments. This factor is a result of the road running through the middle of town, the houses close together and the slag heaps affecting views. Elaine Decker said that there were only 7 grievances this last year and none taken to the Board of Civil Authority.
