- A. Zoning Administrator's Report:

  - Mr. Van Meter provided the Board with a final draft advertisement for the Assistant to the Zoning Administrator position. The Board maintained their unanimous support to have Mr. Van Meter pursue the proper channels to begin advertising.

# Report of the Pawlet Planning Commission to Pawlet Select Board, Tuesday, August 27, 2019

#### **NOTE:**

The September meeting of the Pawlet Planning Commission with be held on September  $23^{rd}$ , the usual  $4^{th}$  Monday of the month. The first community values mapping project public meeting has not been scheduled as of today. We are planning to possibly hold these sessions at the Mettowee Community School. We are waiting for confirmation from the school principal.

#### **Item 1** Town of Pawlet Designation as a 10-Acre Town

• Ed Bove of the RRPC attended our meeting, at which all 7 commissioners and the alternate member were present and attendance included some 30 members of the Pawlet community. Ed came to advise the PPC that, although the Town of Pawlet Planning Commission approved a proposal to change classification of the Town from a one-acre town to a ten-acre town and the proposal was adopted by the Select Board at a public hearing, the final paper work was not completed to make the adoption official. Eric Mach agreed to contact John Thrasher to find out what has to be done to close out this issue. Several members of the community questioned whether the change was actually the best thing for the Town when Act 250 was enacted to help small towns. One member of the community asked why the Town should even bother taking on the extra burden when the Town doesn't enforce the laws we now have.

#### Item 2 Discussions of Open Positions

Harry Van Meter presented a draft advertisement for the position of Zoning Administrator
to take Hal Wilkins' place when he is ready to step down due to illness. Hal has expressed an
interest to Harry to stay on as long as he is able in order to see a few items through to final
resolution. Ed Bove expressed a willingness to help the Town find a replacement. Several
media options for advertising the position were discussed. Elizabeth Gibson stated that she
will assist in this effort.

•	Harry said that the Select Board agreed to advertise for the open position of Clerk of the Planning Commission at the August 13 <sup>th</sup> meeting. Harry will submit a draft to Deb Hawkins for advertising.

#### **Item 3** By-laws Updates and Amendments

Due to the length of time spent on the first 2 items, there was only a brief discussion of the revisions to Article VIII, Section 2 – Zoning Permits and requirements for application acceptance by the Zoning Administrator.

## Item 4 Zoning Administrator's Report

The Zoning Administrator's report was read aloud to the Commissioners and the community attendees.

#### Item 5 Development Grant

Ed Bove asked if the Planning Commission would like to apply for a Development Grant to assist with the cost of updating the Town Plan and other initiatives of the PPC. Ed said that the application is due by the end of September and that the RRPC will assist in our application efforts.

# Zoning Administrator's Report (DRAFT) August 2019

#### **Community Values Mapping Project**

I have advised Monica Pryzperhardt that the Planning Commission will meet this Monday evening and would like to inform the community of the next steps involved in bringing the CVM project (and Act 171 discussions) to a close.

#### Ashley Waite / Cameron Perham - Maple Grove Road

Following a careful review of the Environmental Court;s correspondence - as well as that with the involved parties and their attorneys - the ZA office has issued a *Notice of Violation* to Mr. Perham and has advised him that he has the statutory 7-day period to comply with the Unified Bylaws or the town will initiate an enforcement action and assess a \$100 per day fine against Mr. Perham for each day that the violation persists.

#### Daniel Banyai / Slate Ridge

Finally....and again following discussions with attorney Bent.....the ZA office will issue a *Notice of Violation* to Mr. Banyai. The *Notice* will not reference every site violation - as that will only become apparent following a comprehensive site inspection that will include personnel from the Vermont DEC, VT NRB (Rutland office), VT Fire Safety office, the Pawlet lister's office, etc. [I will include a copy of the *Notice* to you for review and discussion)
