- Monica Kravitt, Pawlett Historical Society Requested a letter of approval from the Selectboard to place a monument of the 1777 expedition on the Town green. Currently, a monument for this historical event exists at the North Pawlet schoolhouse, however Mrs. Kravitt shared that this location lacks accessibility and visibility. Mrs. Kravitt has collected 100+ signatures in favor of this project, as well as pricing and a timeline. Funding would be obtained through grants and fundraising.
  - Members of the public body including Rose Smith, Eve Schaub, Julie Mach, Martin Kravitt and Barry Meinerth, spoke to this topic.
  - With no decisions made at this meeting, the Board indicated that this topic would be discussed at the next regularly scheduled meeting on November 30, 2021, giving them time to review the information presented.
- Lyndsi Barnes, Director of the Pawlet Public Library Spoke to the Library budget, submitted by members of the Library Board at last week's budget discussion meeting, providing additional information supporting the requests.
