- 5. Pre-Requested Appearances by Local Citizens and Visitors:
 - Judy Coolidge & Rose Smith, Pawlett Historical Society
 - Rose reported that she, Perry Brown and Sue LaPorte met to look at the Town Hall Auditorium to assess the electrical capabilities of the space, as they relate to the needs of the upcoming 50th anniversary event. Rose requested that the Board install an appropriate cooling system for the auditorium.
 - Discussion ensued amongst the Board, and the building liaisons will obtain quotes and estimates.
 - The Board addressed the Historical Society's requested assistance for cemetery tree removal and clean-up. The Board asked that the Historical Society gather a second estimate, as well as contact Green Mountain Power, and update the Board on cost before moving forward.
 - James Sheldon, Giving Tree Cannabis:

- Mr. Sheldon requested the Board's support of streetlights, installed by Green Mountain Power, on power poles at both ends of the Giving Tree Cannabis property in West Pawlet.
 - Motion made to draft a letter supporting the existing lighting, installed by Green Mountain Power on the power poles at Giving Tree Cannabis in West Pawlet, VT.

 - Discussion: Jessica Van Oort stated the concern of not having a physical copy of the ANR's notice of possible violation for improper lighting.

- John & Val Davis, West Pawlet Residents:
 - John Davis spoke to ongoing litigation within the Town, and continued to express gratitude and appreciation for Town Attorney, Merrill Bent, for her service.
- Dennis Morrisseau, West Pawlet Resident:
 - Inquired about the old railroad depot building, and proposed a suggested use for the building.
 - The Board, with support of Michael Allen, spoke to the State's position on this building as it currently stands, which is that it be utilized for the purpose of supporting the Rail Trail or to be relocated from state right-of-way property.

 - A. Zoning Administrator's (ZA) Report:
 - Nancy Morlino shared a report from the ZA's office:
 - 4 permits approved in the month of March and all scanning of previous permits have been completed.

 - Nancy attended a Cannabis Control Board permitting meeting.
 - A question was raised regarding the online availability of permits.
 - B. Planning Commission's Report:
 - Jessica Van Oort shared a report from the PPC:

 The PPC reviewed the proposed updates to the Town's Unified Bylaws, which have been proposed with the assistance of Ed Bove of the RRPC.

C. Road Foreman's Report:

- Highway Foreman, Dale Decker, shared a report with the Board:
 - Work is ongoing, tending to mud season road conditions and tending to equipment maintenance.
 - The Vermont Land Trust is surveying the property at the Town Garage to assess use and property lines.
 - The Highway Department applicant has accepted the position of Highway Department Crew Member.
 - VT AOT grant applications are due April 15, 2023.

D. Assessor Report:

- Lisa Wright shared about a proposed bill (H480), moving swiftly through the legislature, which has the potential to impact small towns in Vermont. This bill suggests that the state may take over town reappraisals and grand lists. Lisa encouraged the Selectboard to review this proposed bill, and to consider drafting a letter in opposition to the legislature.
