 - o PPC Chair, Jessica Van Oort, shared a report with the Board:
 - The PPC met on Monday, 5/22, and ZA Nancy Morlino provided an update on the approach other towns are taking on short term rentals: creating registries/ordinances largely in response to safety concerns. Ed Bove from the Rutland Regional Planning Commission reminded the PPC that the Town Plan needs to be updated by February of 2024, meaning the approval process should begin in December of 2023. Pawlet's current Town Plan is strong and should not need any major changes.
 - C. Road Foreman's Report:
 - Highway Foreman, Dale Decker, acknowledged a concern with the Towslee Hill Road sign, which was replaced with a hand painted sign. New regulated sign to be ordered.
