I am commenting on the current situation regarding the dismissal of the library director, based on what I heard at the November Select Board meeting and at the the December 5 Library Board meeting, as well as conversations with quite a few people, and my own experiences with the library as a volunteer sorter, and with Lydsi, mostly with requests for space and publicity for events, including poetry reading and climate change.

There is no question that Lyndsi has been an exemplary librarian in many ways, and has gained the enthusiastic support of many members of the community. She has been helpful and friendly to me. The fact remains that something must have happened to cause the board members to unanimously take the drastic step of dismissing her. The problem for the community is that according to legal advice given to Harley, the Library Board president, no information on the dismissal may be given to the public. Lydsi states that she was given no reason for it, just an email. Some people call for her reinstatement, and others call for an explanation from the Board. Still others say we should trust the integrity of the Board members, and assume that there was a compelling reason.

At the meeting, I said (in less than 2 minutes) that I didn't know what to think, hearing that we weren't going to get an explanation, but that I didn't think the Board was "out to get Lydsi." I have to say now that as much as I admire what Lyndsi has done for the library, I can't overlook the fact that we don't know what happened. I only know two of the board members personally, Hadley and Heather, but I'm willing to believe that they all are reasonable people who did what they felt was right.

It's sad to see the community torn apart with this situation, with strong emotions expressed, and important facts kept hidden. I'm hoping the Board will find a few facts that they could reveal, and Lydsi will ask the board to clarify the reasons for it.

Dear Board Members,

Having worked as an employee in organizations with Boards of Directors and Boards of Trustees I understand something about the laws that govern relations between employees and employers. This is why the facts of Lyndsi Barnes term as Library Director cannot be shared. These laws protect Lyndsi's privacy as much as the Library employer, in this case the Board of Directors. To demand otherwise countermands federal law.

I recognize the difficulty of having to replace a former librarian everyone liked and "the way things used to be done." I also recognize that Lyndsi made some good changes, got grants for special projects — she's also an amazing baker!

However I observed that she appeared to lack respect for library employees and volunteers, for community traditions, and, since she was so often not present at the library, for the regularity our community expects. I went one Saturday morning and found a sign on the library door that said "CLOSED," with no explanation. I found later that the reason was that the building had no heat. Simply stating a reason on the sign would have been a consideration to the community — whose members would have immediately understood. But not providing a reason on the sign left the community adrift.

As a community we elected the Library Board and trusted them with managing library affairs appropriately. To second guess the Board's decisions now reneges our own choice and that trust.

I understand that during her two years employment as Library Director, Lyndsi never received a performance review. How on earth could this not happen?


There must have been some item of dissatisfaction by the Library Board Why on earth did they not sit down with Lyndsi to review the issue and seek a mutually acceptable resolution?

Dear members of the Pawlet Library Board of Trustees,

I write to express my concern and bewilderment at the recent decision of the Library board to dismiss Lyndsi Barnes as Library Director. Although I have not yet seen the minutes documenting that decision posted on the Town website, I understand that you made that decision at your meeting of November 7, 2023. I am struck by its suddenness and apparently total reversal of the board's unanimous support for Ms. Barnes at its meeting of October 24 (just two weeks earlier), in which you agreed to request the Select Board to raise her salary by 10 percent.

Although the board oversees the Director, her salary is paid by the Town. As both a contributor to the Library and a taxpayer of the Town of Pawlet, I believe that the Library board should make every effort for our townspeople to continue to benefit from Lyndsi's service as Director of our Library.

If Ms. Barnes performance was in some way deficient, it is in the best interest of the Library and the Town for the board to communicate that to her and to give her the opportunity to remedy whatever deficiency there may have been. As several of our fellow townspeople noted during the Select Board meeting of November 14, 2023, Ms. Barnes' strengths are significant. (These include the Vermont Library Association's recognition of her outstanding work at the Pawlet Public Library.) We should not be deprived of those strengths at our Library due to mere weaknesses that can be remedied.

Hence, please reconsider your decision of November 7, 2023. If you have observed directly that Ms. Barnes has performed poorly or behaved improperly, please communicate that to her clearly, along with your guidance on any changes needed in her performance or behavior, and please reinstate her as Director so that she may continue to serve us as Library Director while making those changes. If, on the other hand, you have received complaints about performance or behavior so egregious as to require immediate dismissal, I believe you owe it to Ms. Barnes and to our fellow townspeople to carry out an appropriate investigation of those complaints and to share the results of that investigation.

I am disturbed, too, by the comment at the above-mentioned Select Board meeting that Ms. Barnes was dismissed immediately, by e-mail, and without explanation. As trustees of the Library, you owe both Library staff and your fellow townspeople clearer and more respectful communication.
