She will reach out to local libraries (such as Middletown Springs, Wells, Poultney, Rupert, Dorset) and hopefully we can coordinate a get-together in early 2024 to discuss how to best use our resources.

## Committees:

- Personnel, Annual Reviews, and Bylaws have all been suggested and need to meet. Library Budget:
  - Budget was sent out to the Board, expected income and expenses match up so far.

- Harley suggests that the small surplus in the budget should be used for improved furniture, specifically upgraded folding chairs and comfortable seating for the children's room.
- Kathryn motions to add \$5,000 to budget in building maintenance line for furniture improvements, Joni seconds, all agree.
- Harley will ask the Select Board at next meeting regarding legal council for the town/library.
- Harley will edit the budget and get it ready to send to the Town, to be voted on by the Library Board at the December meeting.

#### Annual Appeal:

• This is coming up soon, Harley will ensure the letter is written and printed, and look at the DonorSnap list to make sure it is updated. Letters should be ready to be picked up by Board members for overview by November 27, 2023 and there will be an envelope stuffing party at the library on December 2, 2023.
